


Heritage Oak Cliff, formerly the Old Oak Cliff Conservation League, was formed in 1975 primarily to save Winnetka Heights from a demise that would have left an irreplaceable hole in Dallas history. Today, Winnetka Heights is one of the most beautiful neighborhoods in Oak Cliff and certainly an important part of Dallas' history.

Almost every street one chooses to visit in Oak Cliff neighborhoods has a story to tell and gives important information about how and why Dallas has become a great city. The people who chose to settle here were passionate about the rolling hills and beautiful, mature trees. Many built large gorgeous homes designed by some of the most talented architects of the day. Many built smaller homes also designed by planners and architects with an eye toward quality, durability and family life. Over time, styles changed and new neighborhoods emerged to reflect those changes. Heritage OC views all neighborhoods as partners in promoting Oak Cliff as a wonderful place to live.

Today Heritage counts more than 30 member neighborhoods, stretching from Interstate 30 south to Camp Wisdom Road. From long established neighborhood

associations to smaller neighborhood groups just getting organized, all contribute to the beauty, diversity, and vitality that is Oak Cliff.

For over 40 years, Heritage OC has produced the annual Old Oak Cliff Home Tour. The proceeds of the tour are used to grant awards to member neighborhoods for conservation, beautification and preservation projects and other projects that enhance the character and charm of the area.

Neiko's Story

On May 29, 2018, a handsome, scared Chocolate Lab with a back leg he couldn't walk on and had a pin in it, which you could see, was found on the front porch of a Wynnewood North neighbor. The neighbor contained him and contacted me right



away to scan for a microchip. Luckily, he did have a microchip so the search for his owner's began. According to the microchip information the dog's name is Neiko.

I brought Neiko to my home for safe keeping while waiting on his owner to claim him. The owner on the microchip said she had rehomed him to another individual whom she did not know. After several days of waiting on a phone call from the new owner, I called the previous owner back. It ended up we were never able to locate the new owner and the previous owner did not want him.

Dallas Animal Services was contacted about Neiko and he was listed as "found dog". After the required waiting period, Neiko officially became my dog, although I'm really just fostering him.

Cynthia, a neighbor, researched Neiko's life. She discovered he was adopted from the Allen Animal Shelter several times...5 times to be exact. His first adoption was when he was just 9 months to a family whose daughter was going off to college. Instead of keeping Neiko her parents took him back to the shelter. Next a family with a small child adopted him. That did not work out because the large lab was too much for the small child. He went back to the shelter. Then a man adopted him thinking he would be a companion to run and spend time with. Neiko ended up in his back yard most of the time due to the man traveling with work. Neiko was taken back to the shelter. The next family that adopted him said he was hard to manage since he liked to chew and would break out of his crate. When



he was with this family he was hit by a car. Surgery was performed on his broken leg by a vet in Allen, Texas. A pin and wires were used to fix the broken leg. He had to have surgery a second time on the broken leg because it wasn't healing properly.

This family rehomed him to a neighbor's friend whom they did not know. This family was to follow up with the vet regarding care for the broken leg. That did not happen. Somehow Neiko ended up in our neighborhood.

Thank goodness Neiko ended up on a safe porch in our neighborhood where people cared enough about him to ensure he's had the proper medical care, training, love and attention that he deserves. Brenda and I decided to foster Neiko to ensure he was safe and well taken care of.

Cynthia is very involved with Neiko's care as well as all his medical expenses. She took Neiko to her vet and after multiple visits the pin was removed from his leg. The leg had not healed properly so the next step was major surgery to insert a plate and pins. The surgeon was unsure if Neiko's leg would heal properly due to the previous two surgeries and the fact that it hadn't healed since March. At the time of this surgery it was discovered he had a major bacterial infection in the leg. The vet only gave a 50-50 chance that the leg would heal and not have to be removed.

Neiko went through several months of recovery. This was a very difficult time for all of us as Neiko had to stay still, not run or jump. September 20th was his final visit with the surgeon and he was released with flying colors. The time and effort that Cynthia, Brenda and I put into his care helped ensure he healed properly. The surgeon said he could start doing normal dog stuff but to watch him for one more month.



During the last month of his recovery we were allowed to start training him. Cynthia helped find a trainer and after a few sessions he was ready to learn more and more. Neiko is extremely smart and listens well. Sometimes he does get side tracked, but he is still a puppy. He knows how to sit, stay, wait, lie down, stay back and a multitude of other commands. He is crate trained. He is an

inside dog and is potty trained. He stays in my office if we are away and at night sleeps on his fine big bed. He has never had an accident in the house.

Neiko wants to please and show how smart he is. He loves to run, jump, play tug of war and catch. He has never chewed up anything in the house.

Neiko will be ready for adoption to a new forever home in a few weeks. His birthday is February 14, 2017. He is still a puppy so he needs a family that will continue with his training. He needs a great back yard and someone that will commit to walking him on a regular basis.

With the cooler fall weather, we have been taking longer and longer walks. At home she throws her toys in the air with wild abandon and wanders the backyard watching for squirrels. I feel a kinship with this quiet happy lady, and I'm so glad she is here in our home, for however long that may be. I am grateful to the SPCA for this special opportunity.

FOSTER HEROES

Although fospicing is not for everyone, the SPCA has many other foster opportunities. You can care for puppies/kittens (who can resist a tiny little fur ball of love!), help animals recovering from illness or injury, or assist those needing help with trust building and socialization. They even have a "Borrow a Buddy" program where you can foster a dog for anywhere from 3 hours up to 3 days. This gives the animal some much-needed time away from the shelter environment and provides you an enthusiastic pal to hike, bike, or stroll around town with. Then

there are Adoption Ambassadors, the PR reps of the adoption world, who promote their foster dog online, around town, and at adoption events, helping them find their forever home.

How to Upate Your Information in the Directory—It is simple!

Simply Log-in to the Wynnewood North Web-site (www.wynnewoodnorth.org). Go to the Directory and do a search for your name. After the search, your name will appear in the upper right hand corner of the page. Click on your name and then you will see a button on the left hand side that states "Edit". Click on the button, scroll down until you find the **To see the WWN directory**, Click on the button, scroll down until you find the Emergency Contact information. Enter the information into the various spaces. Be sure and click on the "Save" button before you exit the page.

If you are not computer savvy, contact your Block Captain or Janice Coffee (Communications Directory) to help you get your latest information in the system.

Please NOTE the directory is only available to those who live in Wynnewood North. It is private and not available to the public.

Need New VIPs as patrols are down 27 patrols from last year.

As neighbors move out of the neighborhood and new neighbors move in, Wynnewood North needs to bring in new VIPs to assist in keeping a successful VIP patrol program and help keep our neighborhood Safe. We have a great group of VIPs at this time, but really needing to replace those that have left our fine neighborhood. Also, classes have returned to the Southwest Precinct which is 10 minutes away. We will work around your schedule as this is about keeping the criminal element out of our neighborhood. The VIP Class is a great class that helps you notify those suspicious vehicles, behavior, and people in the neighborhood. You get to meet neighbors, assist in keeping criminal behavior out of our neighborhood, and possibly win a \$50 gift certificate to one of the surrounding restaurants. We need volunteers for 6 hours a year or **more** to help be the eyes and ears of the police department and help assist in keeping Wynnewood North safe from any criminal element. Artist statement: I feel a strong connection to the Japanese concept of Wabi Sabi, sometimes described as an appreciation of beauty that is imperfect, impermanent and incomplete and is often centered on the idea of transience.

Fragility, directness/essence of a thing, repetition, structure, imperfection, process and time, observation of the natural world; these are some of the influences on my work.

It is second nature for me to notice the way things are structured and I am compelled to incorporate elements of focused organization or structure in much of my work.



Attention to my breath, noticing/ present awareness in my mind and body and the world around me inform my work. I am reminded to have a sense of humor about my own imperfections and discomfort in my human condition as I pursue my art practice. Elements of this are reflected in the awkwardness in some of my forms and the 'imperfect" or layered surfaces of found materials and paint in my work. I am curious about materials and various processes and attracted to surfaces that seem to reflect a sense of time and use.

Wynnewood North History— Janice Coffee

A Little History of Wynnewood North for Newcomers

Angus Wynne served in the Navy in the South Pacific during WWII. Upon his return to Dallas, he developed Wynnewood Shopping Center. In Life Magazine (how many of you young people are familiar with that magazine?) dated sometime in 1948 or 1949, there was an article about Wynnewood being THE complete shopping center in the USA. There were shoe shops, a cafeteria, 7-11, Fred's Barbecue where Block Buster used to be, everyone's favorite bakery, Jan's, Titsworth Shoe Repair which is where the present shoe repair shop is located, a

professional building which housed a post office, doctors offices, and a bank. Dress shops such as Volk's (there were monkeys that ran from the front of the store to the back in a see through enclosure just below the ceiling), Margo's, E.M. Khan Roberts Jewelry Store, a fabulous Toy World, a hardware store, several shoe stores and restaurants. A lot of teenagers had their first date at the Wynnewood Theater. Then would

go to the Goff's Charcoal Hamburger that is now a laundromat.

Wynnewood North was developed at the same time. Dr. and Mrs. Jack Harper lived in the house on the southeast corner of Monssen and Llewellyn. Mrs. Harper told me

that Llewellyn ended at her house and there would be a lot of cars drive there at night and park for a period of time (it was a make-out place). My family built the house at 511 Mayrant in 1952; we moved in on March 1, 1953. The model for our house and a number of the floor plans in the neighborhood are on East Illinois by the Cedar Crest Country Club.

The names of the streets are after destroyers which saw action in the South Pacific; the USS Mayrant, USS Monssen, USS Woolsey, USS Bizerte and North and South Manus are after the Manus Islands in the Pacific.


A number of neighbors were small business men and women who owned their own stores or shops. Mr. Wooster from Woolsey had a typewriter repair shop at the intersection of Davis and Bishop where there is an ice cream shop. The Pucketts on Monssen owned the Lullaby Shop on Jefferson, as well as a number of doctors. The Brigham family owned Polar Bear Ice Cream across the street from Lake Cliff Park.

2019 Board of Directors:

October is the time to elect Board of Directors. Each year all positions are up for election. The following is a brief description of each position but for more details on each role visit WNNA website for a more in-depth explanation. Wynnewood North Board of Director Duties

The Members occupying these offices shall constitute the Board of Directors of WNNA, and may, upon majority vote thereof, take action for or develop a posture on issues of concern for WNNA.

The duties of the Officers are as follows:

President

The President will supervise and control the day-to-day business affairs of WNNA and shall exercise such supervisory powers as may be given to him or her by the Board of Directors.

The President shall preside over regular and special meetings of the membership of the WNNA as well as over meetings of the Board of Directors and shall exercise parliamentary control.

The President shall represent WNNA on public occasions.

The President shall make such committee appointments as needed for the effective conduct of the work of the WNNA.

The President shall, with the advice of the Board of Directors and in accordance with the requirements of these bylaws, set the agenda for each meeting of the Board of Directors.

Vice-President

The Vice President shall act in place of the President in the event of the President's absence, inability, or refusal to act, and shall exercise and discharge such other duties as may be required by the Board of Directors. The Vice President shall also act as the Old Oak Cliff Conservation League ("OOCCL") Representative for WNNA and shall be the WNNA liaison between OOCCL and WNNA. The Vice-President's membership in the OOCCL will be paid for by WNNA.

Secretary

The Secretary shall perform all duties incident to the office of Secretary and such other duties as may be required by law, by the Articles of Incorporation, or by these bylaws;

The Secretary shall attest to and keep the bylaws and other legal records of WNNA, or copies thereof;

The Secretary shall take or ensure that someone takes minutes of all meetings of the committees and Board of Directors, and shall keep copies of all minutes;

The Secretary shall ensure that all records of WNNA, minutes of all official meetings, and records of all votes, are made available for inspection by any Member, or Director.

Treasurer

The Treasurer shall collect, safeguard, disburse and make periodic reports of all funds collected in the name of WNNA;

The Treasurer will have charge and custody of all funds of WNNA, will oversee and supervise the financial business of WNNA, will render reports and accountings to the Directors as required by the Board of Directors, and will perform in general all duties incident to the office of Treasurer and such other duties as may be required by law, by the Articles of Incorporation, or by these bylaws, or which may be assigned from time to time by the Board of Directors:





The Treasurer, with the approval of the Board of Directors, shall set up all checking, savings, and investment accounts of WNNA and deposit all such funds in the name of WNNA in such accounts;

The Treasurer's signature shall be the authorized signature for all checking, savings, and investment accounts of WNNA unless the Treasurer, with the approval of the Board of Directors, designates another member of the Board of Directors as the authorized signatory for a particular type of disbursement;

The Treasurer shall prepare a monthly report for the Board of Directors, providing an accounting of all transactions and of the financial condition of WNNA;

The Treasurer shall keep all financing records, books, and annual reports of the financial activities of WNNA and upon reasonable notice, make them available at the request of any Director or Member, or member of the public for inspection and copying.

Social Director

The Social Director shall have charge of coordinating all social activities of the WNNA, including all fund-raising events; Support Senior Neighbors of Wynnewood ("SSNOW") events, National Night Out; the WNNA Spring Fling; the WNNA Holiday Party, and any other special events put on by the neighborhood.

Communications Director

The Communications Director shall act as the WNNA liaison between the neighborhood Block Captains and the WNNA Board, including visiting new residents of the neighborhood, orienting neighbors to the WNNA; distributing "welcome information" packets; coordinating with Block Captains on the distribution of the WNNA newsletter, neighborhood directory and other publications as needed. The Communications director shall coordinate with the Publications Director and Webmaster as needed in order to provide updated information for individual WNNA residents such as a change in the WNNA members contact information; the Communications Director shall also perform such other functions as requested by the President.

Publications Director

The Publications Director shall perform such functions as requested by the President, and shall act as coordinator for all WNNA publications. This include, but is not limited to preparation and coordinating of the WNNA newsletter and the WNNA Directory, coordinating the purchasing, design and publication of advertisements for the WNNA newsletter and WNNA directory and creation of any other special announcements or special events flyers as needed.

Crime Watch Director

The Crime Watch Director shall have charge of coordinating the responsibilities of the neighborhood crime watch, including the organization and maintenance of all crime watch materials of the WNNA, coordinating update of the WNNA crime watch hot-line; the placing of crime alert signs in the neighborhood; attending quarterly meetings with other Crime Watch Directors at the Southwest Patrol Division; and shall also coordinate with the Dallas Police Department's Community liaison. The Crime Watch Director shall coordinate with the Crime Watch Committee on an as needed basis for any special projects relating to the safety and well being of the neighborhood, including but not limited to issues involving crime and/or code compliance.

Beautification Director

The Beautification Director shall be responsible for promoting and encouraging the beautification of the neighborhood, including the Yard of the Month, and making necessary recommendations to the Board of Directors regarding special projects for the beautification of the neighborhood. The Beautification Director shall also coordinate with the Vice President and/or the Beautification Committees or Special Projects Committee on submitting any grant requests to the OOCCL for any project that is to be used specifically for beautification of the neighborhood.





Webmaster Director

The Webmaster shall update the WNNA website on a weekly or "as needed" basis, coordinate obtaining pictures of all WNNA social or special events and posting them on the WNNA website, coordinate with the Board to ensure all information is up to date and accurate (e.g. Yard of the Month, the WNNA calendar, Calloway's Tip of the Month, crime updates, etc.); sending out "blast" email notifications to participating WNNA members.

Parent Liaison Director

The Parent Liaison Director shall facilitate positive interaction between Members and local schools, PTA's and parent support organizations. This person shall initiate child-friendly social activities to increase involvement among residents. This person may also attend various school board meetings and report back to the Members at the General Meeting.


